(Reading and Enrichment for Scholars Plus Other Needed Supplies and Essentials) Program which occurred via pop-up sites at multiple locations and was supplemented by a virtual component. More than 6,000 literacy and enrichment kits were distributed and an average of 1,200 scholars were served per week through in person and virtual learning opportunities.
